1. Assumption of Risk

I EXPRESSLY DECLARE AND AGREE TO ASSUME THE ENTIRE RISK OF ANY AND ALL DAMAGES, OCCURRENCES, ACCIDENTS AND PERSONAL INJURY, INCLUDING BUT NOT LIMITED TO DISABLITY OR DEATH, THAT I AND/OR ATV/ORV MAY SUFFER WHILE PARTICIPATING IN THE ACTIVITIES. I hereby undertake and agree, while using ATV/ORV and participating in the activities, to respect and comply with all applicable laws, rules and regulations governing the ATV/ORV, comply with directions and/or instructions given, including without limitation the content of attached safety checklist. I shall be responsible for all fines, penalties and property damage I may incur, personal injuries or property damage incurred by others as a result of my conduct when participating in the Activities.
